Sugarloaf Cobbitty Equestrian Club Inc. Conditions of Entry and Rules and Regulations

1. This event will be held in accordance with current EFA Dressage Rules as amended except where FEI Rules apply. The Committee may grant exemptions to the rules for special promotional competitions. **The responsibility is on the competitor to know the rules.** The conditions below are relevant for competitions held by SUGALOAF COBBITTY EQUESTRIAN CLUB.
2. **Official & Associate** competitions: Refer current 2008 EFA Dressage Rule Book.
3. **Horses/ponies:** All competitions (unless otherwise stated) are open to horses or ponies. Please indicate on the entry form if your horse is a pony.
4. **Height of horses and ponies:** Refer current 2008 EFA Dressage Rules.
5. Riders may be changed before the start of competition; however, a rider of a horse may not be changed if another rider has ridden the horse on the day, either in warm-up or in a competition. Horses cannot be changed. Draw position cannot be changed without the permission of the Organising Committee. One rider per horse for the entire event.
6. **HORS CONCOURS** (Non competitive): Riders wishing to ride HC/NC must declare their intention **in writing** before the **start of competition** (test).
7. Riders or owners who have an **outstanding debt** with SUGALOAF COBBITTY EQUESTRIAN CLUB will not be permitted to enter a horse or compete in any event run by SUGALOAF COBBITTY EQUESTRIAN CLUB until that debt has been settled.
8. Entries are taken on a first in basis. Telephone/Late entries will not be accepted.
9. Bridle & EFA numbers must be shown on entry form and are mandatory for both Associate and Official tests. If awaiting issue of either please indicate on entry. Bridle numbers (2) - one on either side of the horse, must be clearly displayed so that the judge can identify the rider when riding in front of the judges' vehicle. Riders are not required to stop at the judge's car.
10. **Scratchings** will be accepted up to the closing date. **Refunds** as per EFA rules. Should a competition be cancelled we may charge an administration fee of \$10. This will be refunded in due course.
11. DNAs, riders will automatically be placed on the reserve list the next event they enter if the competition is oversubscribed.
12. In the case of oversubscription, entries may be limited and a **max. of two horses per rider will apply**. The event is open to all EFA members. SUGALOAF COBBITTY EQUESTRIAN CLUB members will be given preference if oversubscribed. Only one rider may ride a horse at the event.
13. Grading Points and eligibility to compete at FEI level: As per current EFA rules.
14. Veterinary checks: Random swabbing may take place. If approached by Official Steward/ Vet Officer of the day, competitors/person responsible for horses must allow samples to be taken from their horses for drug tests.
15. Registration and Performance Cards must be available on the day of competition.
16. **Entry Fees:** (GST Inc.) Unless otherwise stated in the event schedule, **Official: Members-** \$22.00 per test for; **Non Members -** \$30.00 per test. **Associate: Members -** \$20 per test; **Non Members -** \$28 per test. FEI Members \$27 Non Members \$35
17. **Prizes** are awarded at the discretion of the SCEC Committee and maybe subject to the number of competitors and whether the test is associate or official. **Ribbons** are awarded as per 3.18 – Awards and Placings of the EA Dressage Competition Rules 2008.
18. Please use the SUGALOAF COBBITTY EQUESTRIAN CLUB specific entry form to enter this event. Download from the web site. www.scec-dressage.com
19. **Stabling:** Stables are available on the grounds. **SUGALOAF COBBITTY EQUESTRIAN CLUB accepts no responsibility for the condition or state of repair of the stables. Camping:** Available on the grounds. If stabling is required, or camping please phone Sugarloaf directly on (02) 46 51 2489.
20. No lunging allowed in warm up area. An enclosed lunging yard is available.
21. **Gear Check** – all competitors must present to the Gear Steward. Failure to do so may incur elimination.
22. **No dogs** are allowed anywhere on the ground of Sugarloaf Equestrian Centre. Prams, children unaccompanied by an adult etc., will not be permitted in the competition area for safety reasons.
23. Conditions for Riding Attire & Hats. As per EFA Rules or special conditions covered in the competition schedule.
Training and practice Helmet (approved safety helmet)
Competition (inc. final warm-up): Riders under 18 years: Helmet up to and including medium level. As per EFA/FEI Rules at higher levels 18 and over: As per EFA/FEI rules. SUGALOAF COBBITTY EQUESTRIAN CLUB allows competitors **who are warming up before their tests to warm up in the sand warm-up arenas in competition attire**. At all other times when training in other areas at the venue, an approved safety helmet as per above must be worn.
24. Video Cameras and equipment must be kept at least 10 metres from the arena, preferably at the A end of arena.
25. No temporary yards/fences made substantially of electrical fencing/rope or similar material is to be used to construct yards/fences in float or car park/camping areas.
26. Any power or authority vested in the committee by these conditions of entry may be exercised by the Official of the Day or, with the concurrence of that person, any member of the committee. The "Official of the Day" is the person from time to time nominated by the committee as such. Any rider who fails to comply with these conditions of entry, or a direction of a member of the committee, may be eliminated.
27. Online entries: Scratchings before the closing date is entitled a refund (less 5.5% Nominate fee). Competitors who enter the event on line and who wish to withdraw before the closing date need to contact Nominate direct to cancel their entry. Scratchings after the closing date is entitled a refund (less 5.5% Nominate fee) only if supported with either a vet or doctors certificate.
28. Should a competition be cancelled we may charge an administration fee of \$10.

Notice to all competitors: The welfare of the horse is paramount.

If at any time it appears to a member of the Committee of SUGALOAF COBBITTY EQUESTRIAN CLUB that a horse may for any reason require veterinary attention, and (a) the rider, or other person apparently in charge of that horse, is not immediately available to attend to that horse's welfare, or (b) such rider or other person declines to adequately attend to that horse's welfare, the member of the Committee is authorised to call in veterinary assistance for the horse, and the veterinarian attending is authorised to administer to the horse such treatment (including euthanasia) as the veterinarian considers appropriate in the circumstances. The rider of the horse is responsible for and must meet the cost of such veterinary treatment. A rider who does not meet that cost will not be permitted to enter any future competition conducted by SUGALOAF COBBITTY EQUESTRIAN CLUB."

Riders and owners of competing horses and other people associated with them must, under penalty of elimination, obey any order or direction given to them by any responsible official (judges, official of the day, committee members, gear steward) and they must, in particular, be careful not to do anything liable to upset or hinder the undisturbed progress of the competition.

Competitors please note: Only horses that are entered for the competition are permitted on the grounds during the event. Riders competing on Sunday are allowed to bring their horses to the grounds on Saturday. Reserve listed horses/riders may attend on the day/s entered for the competition.

Spectators/visitors are welcome at all times.
